- Affordable Care Act
  - Amy Grippi reviewed the special section in the Act for Foster Care Youth
    - Must be in care on or after 18<sup>th</sup> birthday and receiving medical assistance to be eligible. Can receive assistance up to age 26
    - Youth still in care as of January 1, 2013, will automatically be enrolled
      - ✓ Must re-enroll every year
      - ✓ Will receive paperwork to complete every year. Make sure these are completed and returned in or to continue the coverage
    - Youth over 18 and have left care must apply for medical assistance.
      - ✓ Go on line to the compass
      - ✓ County assistance office
      - ✓ Several different ways- check to find out where to go

- ✓ Make sure you check *Former Foster Youth*
- ✓ Youth are encouraged to apply now if they have left care
- PA is covering youth who were in foster care in another state and moved to PA. If a Pennsylvania youth, in foster care, moves to another state that youth must check with the that states policy to see if they would be able to receive the assistance in that state
- Make sure you provide all documentation they ask for
- All foster care youth are eligible, even if they have a job
- If you're having difficulty applying or receiving coverage for youth already in care, the best place to start is the local county assistance office
- The former Foster Care category is a new category, they will look at all information provided first
- At age of 21 the health insurance does change. There is less coverage for all adults
- Communication will sent to the Children and Youth offices soon
- Flyer being created to get out to youth as soon as possible to get the word out to all youth, even those who left, as soon as possible
- Documentation will be sent to the county offices soon
- Federally Affiliated Market Place is where everyone is encouraged to go to apply. Go into the state medical assistance website and apply through Compass because that is where the application will end up
- If the youth has a child they should applied together
- Documentation needed
- If the youth was in care in PA, they should be in the county assistance database and should not have to provide any documentation.
- If the youth came from another state they will need to get proof from the state they came from
- If the youth is over 18 and still in care they will be automatically enrolled. If they leave care, they need to update their address. The office cannot forward mail.

- Independent Living Practice Standards – A document was created in 2006 by the South Central Region and the Juvenile Law as a start for youth developed standards. They were sent to several places / individuals statewide; however, there was not any further implementation to assure these standards were used. They began to revisit and see how it could be more user friendly and what things may have changed. They brought it to the Statewide Board for review and recommendations to see what is missing.
  1. Broke up into four groups to review and document via flip charts the four different sections
    - a. Dating: Privileges and responsibilities
    - b. Housing/ Placement Options
    - c. Various Privileges
    - d. Curfew / College and Education
    - e. Friends and Working Guidelines
- Report-out for Practice Standards – The report-outs were mailed out – and also attached to these minutes
- YAB members are to take the draft to your local regions and compile more youth feedback from the regions. Once feedback is obtained, the suggestions should be emailed to Janice at [jtc30@pitt.edu](mailto:jtc30@pitt.edu). Janice will compile the suggestions. They will be distributed at the January Statewide YAB meeting and a vote will be taken on what will be included. Once vote is taken it will be compiled and send to system partners i.e. OCYF, AOPC, County Administrators, etc in order to address their concerns and have them sign on to it to strengthen our c. Once signed off, it will be the YAB Regions responsibility to present to the various counties
